1. Introduction

Staatsolie Maatschappij Suriname N.V. ("Staatsolie") hereby invites qualified and experienced service providers to submit an Expression of Interest (EOI) for prequalification regarding the execution of **Waste Treatment Operations** at Staatsolie Upstream Onshore Facilities.

The selected contractor will be responsible for providing end-to-end waste treatment operational services including waste handling, treatment, recycling coordination, disposal activities, reporting and HSE compliance across Staatsolie's designated waste treatment facilities.

2. Project Overview

Staatsolie intends to establish a Framework Agreement for a period of three years with a qualified contractor for the execution of Waste Treatment Operations at its Upstream Onshore Facilities.

The agreement is expected to cover operational services at:

- Landfarm Facilities
- Waste Management Facility (WMF)
- Dumpsites
- Other designated upstream operational locations

The contractor shall provide qualified personnel, management systems, reporting capabilities, HSE compliance and operational support required to maintain safe, efficient and environmentally compliant waste treatment operations.

Framework Agreement for the Supply of Commodity and Specialty Chemicals	The Contractor shall: • Execute waste segregation and classification activities; • Prepare and package waste for transportation; • Handle domestic, industrial and contaminated waste streams; • Operate and maintain waste treatment processes including: ○ Landfarm and bioremediation systems; ○ Incineration systems; ○ Centrifuge and oil recovery systems; ○ Water treatment systems; • Coordinate recycling activities with approved third-party recyclers; • Ensure environmentally compliant disposal methods; • Maintain accurate operational records and waste tracking data; • Register required waste information in Staatsolie's PPP application; • Submit operational, inspection and KPI reports; • Ensure compliance with Staatsolie HSE procedures; • Ensure compliance with ISO 9001, ISO 14001 and ISO 45001 requirements; • Provide qualified and competent personnel; • Ensure operational continuity and minimize downtime; • Participate in performance evaluations and audits; • Maximize local content through employment, training, subcontracting and knowledge transfer initiatives.

4. Eligibility and Supplier Associations

Contractors may be:

- Local companies registered in Suriname; or
- International companies.

Where contractors form Joint Ventures, partnerships or consortiums, the nature of the association shall be clearly described.
