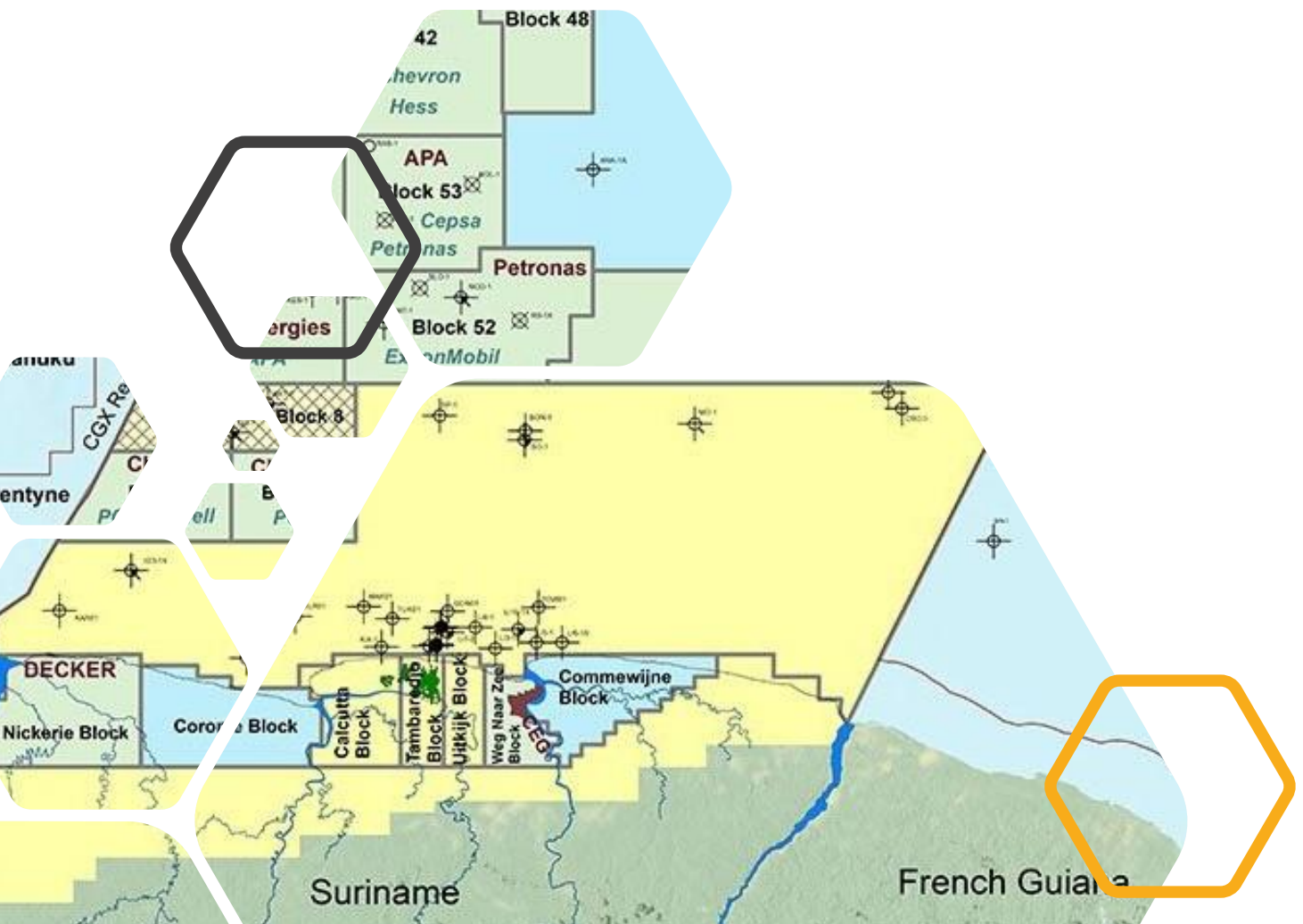

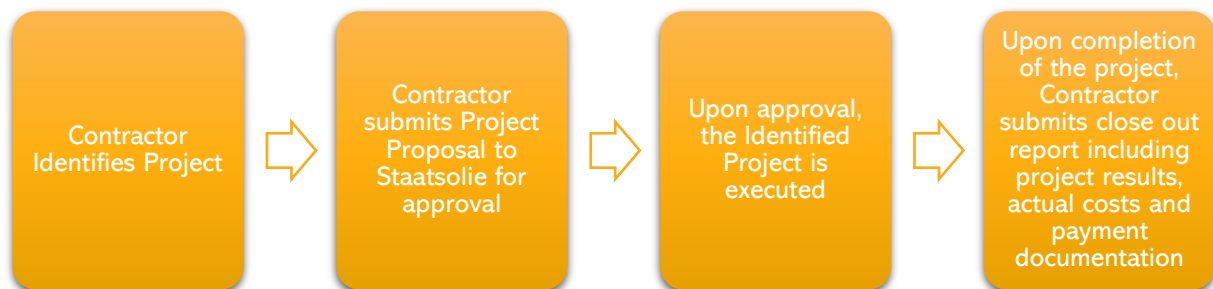
## FOREWORD

Within the aim to maximize the value of the petroleum activities in Suriname, Staatsolie Hydrocarbon Institute N.V. (SHI) monitors the contractual obligations stated in the Production Sharing Contracts (PSC), on behalf of Staatsolie Maatschappij Suriname N.V, and specifically the contribution to the sustainable development, health and welfare of (for) the people of Suriname.

In 2022, Staatsolie monitored 11 active PSC's of which 9 in the offshore and 2 in the onshore. Even though, every Contractor has its own Social Responsibility philosophy and/or strategy, the Social Investment Obligations in the Production Sharing Contracts state an agreed amount and should contribute to support community-based development in areas like environment, health, education, culture and sports.

In order to fulfill their Social Responsibility Investment obligations, the Contractors need to follow the Social Responsibility Framework and its Project Approval Process.

### Project Approval Process



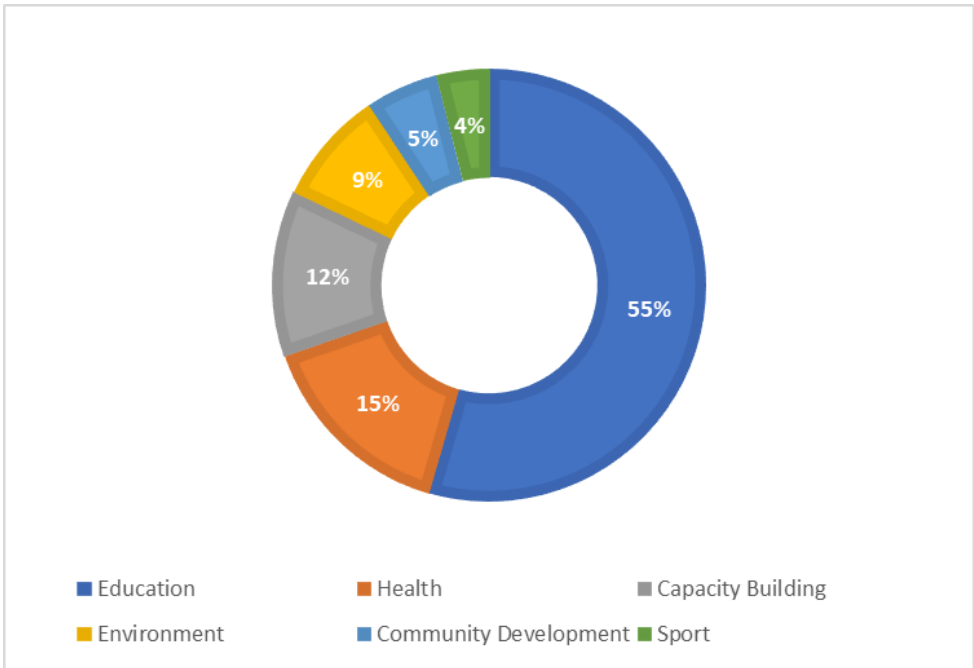

SOCIAL RESPONSIBILITY FOCUS 2022

The Social Responsibility projects that have been approved in 2022 are focused on:



The total amount of USD 1,015,295 was approved on the focus areas with the majority amount of USD 553,000 (55%) invested on Education projects.



## EDUCATION

The main contribution in 2022 has been to Education, by committing to support private and government institutes to prepare for the oil and gas development in Suriname. Besides oil and gas development, the identified projects also aim to stimulate and promote STEM (Science, Technology, Engineering, Math) education and support in upgrading facilities, equipment and curricula.

The focus and support of the healthcare in Suriname continues through the contribution of equipment in the various hospitals across the country.

## ENVIRONMENT

The focus on the rehabilitation of the 5 km coastline of Mangroves at Weg naar Zee continues together with educational and awareness projects on the conservation of the mangroves. Steps are being taken to address plastic waste and support of a circular economy where post-use plastic is recycled, reused, or repurposed.
